Bayfield's Family Based Care (FBC) program is designed to meet the individual needs of children and youth who are ready and able to live in a family setting. Our core outcome objective is for children to form healthy attachments. In this highly supportive environment, the child with a history of adversity is helped to: develop supportive relationships with adults; form peer relationships; develop socialization skills; focus on self-worth; engage in appropriate behaviour; practice life skills, and; manage stressful situations.

Bayfield places a high importance on the support offered in the Family Based Care program. Foster providers are selected and vetted through the SAFE Home Study program. They meet with a Program Supervisor for support, to ask questions and plan for treatment and care on a regular basis. In addition to regular site visits, the Program Supervisor conducts annual reviews of the homes, offering the Foster providers recommendations for improving the services offered to our youth. The continued support of Bayfield's clinical services, psychiatric monitoring, private school and crisis response personnel are available as required, on a fee-for-service basis, for homes located in Hastings and Prince Edward Counties.

We also have several homes in the Greater Toronto Area (GTA), including the central city of Toronto and the four regional municipalities of Durham, Halton, Peel and York. Our foster providers in the GTA represent the culturally and ethnically diverse population of this region. These families are also selected and vetted through the SAFE Home Study program; are visited by the Program Supervisors on a regular basis and; in addition to regular site visits, the Program Supervisor conducts annual reviews of these homes as well. Educational and health services are provided within the communities that the homes are located in and we have an extensive list of direct care staff that are available to provide additional support to the youth and families as required.

Access to a Clinical Therapist, Program Supervisor and Director for crisis support is available to our Foster Parents 24 hours a day, 7 days a week.

Bayfield offers the following additional services that are available for purchase through separate per diems:

Clinical Services: required psychological and psychometric testing used to inform treatment and educational planning, provided by Psychologist, Dr. Niki McGill; psychiatric consultation, assessment, diagnosis and monitoring of psychotropic medications, provided by Child and Adolescent Psychiatrist, Dr. Susan Reddick, and; weekly individual counseling provided by one of Bayfield's clinicians.

Day programming and enrolment in Bayfield School: elementary or secondary educational programming in a private school inspected bi-annually by the Ontario Ministry of Education and structured to meet the

Bayfield's Foster Parents will have completed the following training, before being approved to provide foster care and before children/youth are admitted to their home:

- The Parent Resources for Information, Development, and Education, (PRIDE) Pre-service Training; or The Strong Parent Indigenous Relationship Information Training (SPIRIT)
- First Aid/CPR certification which includes infant and child CPR (current certificate required)
- A review and working knowledge of the Bayfield Policies and Procedures

Within 6 months of approval, the new Foster Parent will complete:

- Training on Providing Trauma-Informed Care.
- FNIM Cultural Competency Training (this training is not required if the person identifies themselves as an FNIM person).

Managers and direct care staff Working in the homes, whether directly employed by Bayfield or hired through an employment agency, require at least 2 years of postsecondary education in a related field of study or twice the amount of related experience (4 years, or 8320 hours) in working with youth in a residential or school environment. The certificate, diploma or degree program must have included content, both academic and practical, that is directly relevant to the person's duties, programming provided at Bayfield, and the needs of the youth placed at Bayfield. In addition to their pre-service education/ experience, direct care staff are provided with the following training:

- Medication administration (full-time staff)
